Membership in the NITRD Program

The Networking and Information Technology Research and Development (NITRD) Program was established by the High-Performance Computing Act of 1991 (P.L. 102-194) and reauthorized by Congress in the American Innovation and Competitiveness Act of 2017 (P.L. 114-329). The NITRD Program provides a framework and mechanisms for coordination among the Federal agencies that support advanced IT R&D. The benefits and responsibilities of NITRD membership are outlined below:

Benefits of NITRD Membership

- Influence national and global NIT research strategies and priorities by interfacing with NITRD members representing diverse mission agencies
- Innovate more effectively by participating in a multi-agency coordination program with a proven record of accelerating the deployment of advanced and experimental information technologies
- Work synergistically and collaboratively with multiple agencies to address NIT research gaps, avoid overlapping efforts, leverage existing work, and develop multi-agency, multidisciplinary R&D programs and activities
- Keep well-informed about NIT research programs and the overall Federal NIT R&D
 portfolio investment by participating in timely and relevant program information-sharing
 activities and events
- Participate in workshops, meetings, and other events involving the public, academic, and private sectors to ensure interoperability in critical NIT areas and the transfer of R&D innovations
- Partner with other NITRD member agencies in the vanguard of sustaining U.S. leadership
 in NIT R&D by aligning strategic priorities and NIT R&D requests in the annual NITRD
 Supplement to the President's budget

Responsibilities of NITRD Membership

- Assign a representative and one or more alternates to serve on the NITRD Subcommittee
- Assign a representative(s) to participate actively in the Program Component Areas where funding is reported in the NITRD Budget crosscut and in other working groups, as appropriate
- Provide inputs to the annual NITRD Supplement to the President's Budget
- Provide proportional funding to support the NITRD/NCO operations, which includes
 project management, technical, financial, information technology, networking, and
 administrative support services in support of the NITRD Program. These specific services
 include:
 - o Technical coordinator(s) with subject matter expertise to facilitate the coordination and collaboration among the interagency working groups

Membership in the NITRD Program

- o Project and administrative support services to facilitate conference/meeting, logistical planning, and administrative services support
- o Technical writing and editorial support for the NITRD Supplements to the President's Budget, federal/strategic plans, and other technical reports
- Budget analyst and administrative support services to facilitate budget development and maintenance of NITRD's funds, and internal controls to ensure transparency and accountability
- o Project and resource management support and services
- o Network and website services and support to facilitate the development, maintenance, and security of nitrd.gov services
- o Infrastructure services and support provided by the host agency (rent and other administrative services)
